**DECISION**  
**ON RECOGNITION OF BONDED WAREHOUSE**

*Pursuant to Decree No.68/2016/NĐ-CP dated July 01<sup>st</sup> 2016 of Vietnam Government regulating on conditions for duty-free business, warehouses, sites for customs clearance, customs inspection and supervision;*

**DECIDES**

**Article 1.** Recognition of bonded warehouse of Quy Nhon Port Joint Stock Company as follows:

- Address: Quy Nhon Port, Binh Dinh province.
- Area of recognition is 2,808 m<sup>2</sup> including: area of warehouse served for storing goods is 2,736 m<sup>2</sup>, area of warehouse served for storing exhibits is 32.5 m<sup>2</sup> area of working office of local customs officers is 22 m<sup>2</sup> (located in area of office of Quy Nhon Port, separately from the bonded warehouse) (details as enclosed file)
